# DLA Piper's lawyers train refugees

**The international law firm DLA Piper is mobilizing in Luxembourg in a training and integration campaign for refugees. All of it voluntarily. The initiative coordinated by a Somali refugee is called Know Your Rights.**

"For nine weeks, our lawyers volunteered in English and translated into French and Arabic, in different subjects: labor law, contract law, asylum and immigration law, housing and health rights, but also on the Luxembourg judicial system, the techniques of negotiation, entrepreneurship, oral and written presentations. "

Behind each participant lies a story, a journey. They have also often risked their lives to get where they are today in Europe.

"Most of the participants had a good career in their country, a job, a business," adds Margaux Bia. Our goal here is to give them all the necessary information so that they can find housing, work, a school for their children, enroll in university or start their own business. "

Before the organization of the courses in Luxembourg, the Know Your Rights campaign was first launched in Amsterdam in 2017, then in Paris, Cologne, Milan and Vienna. It will also be soon in England and Thailand.

In our country, the initiative was set up by DLA Piper in collaboration with the non-profit organization Passerell, the University of Luxembourg, the non-profit organization Ryse, as well as a refugee from Somalia and law student at the University of Luxembourg, Emanuel Kamura, who coordinated the entire project for three months.
